RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 02, SERIES OF 2025 OF THE MUNICIPALITY OF ILOG, NEGROS OCCIDENTAL APPROVING THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 2 OF THE SAID MUNICIPALITY IN THE TOTAL AMOUNT OF ONE HUNDRED SIXTY MILLION PESOS (P160,000,000.00)

WHEREAS, thereby presented to the Board for review and appropriate action is the Appropriation Ordinance No. 02, series of 2025 of the Municipality of Ilog, Negros Occidental approving the 2025 General Fund Supplemental Budget No. 2 of the said Municipality in the total amount of One Hundred Sixty Million Pesos (P160,000,000.00) that was submitted to the Sangguniang Panlalawigan for review on May 2, 2025;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A 7160, otherwise known as the Local Government Code of 1991, CY 2016 Updated Budget Operations Manual for Local Government Units, implementing circulars and other issuances as pre-reviewed and endorsed by the Local Finance Committee through the Provincial Budget Office;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 02, series of 2025 of the Municipality of Ilog, Negros Occidental approving the 2025 General Fund Supplemental Budget No. 2 of the said Municipality in the total amount of One Hundred Sixty Million Pesos (P160,000,000.00), subject to the following conditions:

- The purchase and specification of the motor vehicles shall be subject to the provisions of Administrative Order No. 14 dated December 10, 2018; Budget Circular (BC) No. 2022-1 dated February 11, 2022 and BC No. 2022-1A dated March 1, 2023 of the Department of Budget and Management (DBM);
- 2. That Section 56 in relation to Sections 326 and 327 of the Local Government Code provides that within 3 days after approval of the Ordinance authorizing annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said Ordinance to the appropriate reviewing authority.

**RESOLVED FURTHER**, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with the existing laws, rules and regulations shall be the responsibility of the city government.
