RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 43, SERIES OF 2025 OF THE MUNICIPALITY OF LA CASTELLANA, NEGROS OCCIDENTAL ENTITLED: "AN ORDINANCE RENAMING BALUCANAG ELEMENTARY SCHOOL TO BENJAMIN M. REGALADO SR. ELEMENTARY SCHOOL" AS A VALID ENACTED ORDINANCE SUBJECT TO PRIOR CONSULTATION WITH THE NATIONAL HISTORICAL COMMISSION OF THE PHILIPPINES

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is Municipal Ordinance No. 43, Series of 2025 of the Municipality of La Castellana, Negros Occidental entitled: "AN ORDINANCE RENAMING BALUCANAG ELEMENTARY SCHOOL TO BENJAMIN M. REGALADO SR. ELEMENTARY SCHOOL";

WHEREAS, the subject Ordinance finds legal support from the Local Government Code of 1991, (RA 7160), specifically, Section 13 (c) (3);

WHEREAS, Department of Education Order No. 40, Series of 2014 clarifies that Section 99 (d) of Republic Act 7160 authorizes the <u>Local Sanggunian to change the name of schools</u> through an ordinance, with the Local School Board as the recommending body;

WHEREAS, DepEd Order No. 29, Series of 2011 establishing the Revised Guidelines on the Naming and Renaming of Schools reiterates in item 3 that Consultation with the National Historical Commission of the Philippines is required pursuant to the aforementioned Section 13 of the Local Government Code;
