RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 25-01 OF THE CITY OF SAN CARLOS, NEGROS OCCIDENTAL ENTITLED: “AN ORDINANCE APPROPRIATING THE AMOUNT OF TWENTY SEVEN MILLION EIGHT HUNDRED TWENTY TWO THOUSAND FOUR HUNDRED TWELVE PESOS (P27,822,412.00) FOR THE GENERAL FUND SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2025 OF THE CITY OF SAN CARLOS, NEGROS OCCIDENTAL”

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is Appropriation Ordinance No. 25-01 of the City of San Carlos, Negros Occidental entitled: “AN ORDINANCE APPROPRIATING THE AMOUNT OF TWENTY SEVEN MILLION EIGHT HUNDRED TWENTY TWO THOUSAND FOUR HUNDRED TWELVE PESOS (P27,822,412.00) FOR THE GENERAL FUND SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2025 OF THE CITY OF SAN CARLOS, NEGROS OCCIDENTAL”;

WHEREAS, the pre-review thereof shows apparent compliance with the same law, its Implementing Rules and Regulations, Budget Operations Manual for Local Government Units, 2023 Edition and implementing circulars and other issuances;

WHEREAS, said Appropriation Ordinance is therefore recommended for approval and considered operative in its entirety effective April 23, 2025 subject to the posting requirements under Section 59 of the LGC of 1991 and subject further to the following conditions:

1. *The Human Resource, Position Classification and Staffing Actions shall be consistent with the rules and regulations established under Civil Service Commission Memorandum Circular 12, s. 2022; CSC Memorandum Circular No.24, 2. 2017, as amended by CSC MC No. 14, s. 2018; Local Budget Circular No. 53;*

Budget Circular No. 2019-1; and other existing guidelines and policies. Position Titles and Salary Grades shall conform to Local Budget Circular No. 137 dated July 13, 2021 of the Department of Budget and Management (DBM). Creation of positions shall be subject to the condition, among others, that the Salary Standardization Law has been fully implemented. Furthermore, in cases of abolition of positions and the creation of new ones resulting from the abolition of existing positions in the career service, such abolition or creation shall be made in accordance with pertinent provisions of the LGC and civil service laws, rules and regulations;

- 2. The payment for Magna Carta for Public Health Workers (PHWs) shall be in accordance with DBM-Department of Health (DOH) Joint Circular (JC) No. 1 dated November 19, 2012, as amended by DBM-DoH JC No. 1 dated July 15, 2016;*
- 3. The payment of Personnel Economic Relief Allowance shall be pursuant to Budget Circular Nos. 2009-3 dated August 18, 2009, and 2011-2 dated September 26, 2022 of the Department of Budget and Management;*
- 4. The payment of Uniform/Clothing Allowance shall be pursuant to Budget Circular No. 2024-1 dated April 4, 2024 of the DBM;*
- 5. The grant of Productivity Enhancement Incentive shall be pursuant to Circular Letter No. 2024-17 dated December 4, 2024 of the DBM; and*
- 6. The Local Chief Executive (LCE), upon approving the AO, shall sign in every page thereof pursuant to Section 54(a) of the LGC, which provides that, "every ordinance enacted by the Sangguniang Panlalawigan, Sangguniang Panlungsod, or Sangguniang Bayan shall be presented to the provincial governor or city or municipal mayor, as the case may be. If the LCE concerned approves the same, he shall affix his signature on each and every page thereof.xxx.*

WHEREAS, the Committee on Finance, finding all the necessary documents to be in order, deemed it best to approve the same;

NOW THEREFORE, on motion of Hon. Rommel T. Debulgado, unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 25-01 of the City of San Carlos, Negros Occidental entitled: "AN ORDINANCE APPROPRIATING THE AMOUNT OF TWENTY SEVEN MILLION EIGHT HUNDRED TWENTY TWO THOUSAND FOUR HUNDRED TWELVE PESOS (P27,822,412.00) FOR THE GENERAL FUND SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2025 OF THE CITY OF SAN CARLOS, NEGROS OCCIDENTAL".

RESOLVED FURTHER, it is understood that the review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

RESOLVED FINALLY, the accuracy of the statements/certification and other supporting documents contained in the supplemental budget as well as compliance with the existing laws, rules and regulations shall be the responsibility of the city government.
