## **RESOLUTION NO. 0640** Series of 2025

RESOLUTION APPROVING ORDINANCE NO. 03, SERIES OF 2025 OF THE MUNICIPALITY OF VALLADOLID **FOR** THE REVERSION OF THE SAVINGS/UNUTILIZED FUND FROM PS SAVINGS AMOUNTING TO **FOUR** MILLION ONE HUNDRED SEVENTY NINE THOUSAND SIX HUNDRED NINE PESOS (P4,179,609.00); AND MOOE (SPA) - SUPPORT TO EDUCATION (LGU-EQUITY- CPSU- VALLADOLID BRANCH PPAs) AMOUNTING TO TWO MILLION SEVEN HUNDRED FIFTY NINE THOUSAND SIX HUNDRED FIFTEEN PESOS (P2,759,615.00), IN THE TOTAL AMOUNT OF SIX MILLION NINE HUNDRED THIRTY NINE THOUSAND TWO HUNDRED TWENTY FOUR (P6,939,224.00) FROM FY 2025 MUNICIPAL GENERAL FUND BUDGET INTO SAVINGS

WHEREAS, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned:

WHEREAS, the subject ordinance is within the provision of Section 322 of the Local Government Code of 1991 (RA 7160) and Article 454(b)(1) of its Implementing Rules and Regulations which requires the submission of detailed Statements of Income and Expenditures to the sanggunian and furnish the Department of Budget and Management (DBM) with the Quarterly and Annual Statements of Income and Expenditures. This aims to promote transparency and accountability in the financial affairs of the LGUs;

WHEREAS, the reviewing authority of the Sangguniang Panlalawigan finds no irregularity that follow thereto as a result of the thorough scrutiny of the Provincial Legal Officer;
