RESOLUTION GRANTING AUTHORITY TO THE PROVINCIAL TREASURER TO CHARGE AGAINST THE CURRENT BUDGET OF THE PROVINCIAL HEALTH OFFICE UNDER TRAVELLING EXPENSES ACCOUNT (5-02-01-010), THE TEV AND PER DIEMS COVERING THE PERIOD OF OCTOBER 4, 21-25, 2024 OF REGALADO AGUHAYON IN THE TOTAL AMOUNT OF SIX THOUSAND EIGHT HUNDRED THIRTY FIVE PESOS AND SEVENTY THREE CENTAVOS (\$\mathbf{P}6,835.73) WHICH WAS OBLIGATED BUT NOT BOOKED-UP FOR PAYMENT AT THE PROVINCIAL ACCOUNTING OFFICE
