RESOLUTION APPROVING RESOLUTION NO. 109-2025 OF THE MUNICIPALITY OF VALLADOLID, NEGROS OCCIDENTAL, ADOPTING THE ANNUAL INVESTMENT PLAN (AIP) FOR BUDGET YEAR 2026 OF THE SAID MUNICIPALITY

WHEREAS, thereby presented to the Board for review and appropriate action is Resolution No. 109-2025 of the Municipality of Valladolid, Negros Occidental, adopting the Annual Investment Plan (AIP) for Budget Year 2026 in the total amount of Eight Billion Four Hundred Ninety Two Million Pesos (P8,492,000,000.00);

WHEREAS, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlangsod or Sangguniang Bayan concerned;

WHEREAS, a review of the said ordinance shows that the same is in accord with the provisions under Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandating Local Government Units to formulate their local development plans/programs/projects/activities based on their respective thrusts/priorities;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;
