RESOLUTION GRANTING AUTHORITY TO THE PROVINCIAL GOVERNOR, TO SIGN FOR AND ON BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND THE MUNICIPALITY OF MURCIA RELATIVE TO THE REFERRAL OF PATIENTS OF THE MURCIA MAIN PRIMARY CARE FACILITY (MMPCF) FOR PHARMACEUTICAL AND DENTIST SERVICES TO THE TERESITA L. JALANDONI PROVINCIAL HOSPITAL EFFECTIVE UPON SIGNING THEREOF AND SHALL CONTINUE FOR A PERIOD OF ONE YEAR UNLESS TERMINATED EARLIER BY EITHER PARTY

WHEREAS, the request from Gov. Eugenio Jose "Bong" Lacson, dated May 9, 2025, has been forwarded to the Sangguniang Panlalawigan concerning the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental and the Municipality of Murcia relative to the referral of patients of the Murcia Main Primary Care Facility (MMPCF) for pharmaceutical and dentist services to the Teresita L. Jalandoni Provincial Hospital (TJLPH) effective upon signing thereof and shall continue for a period of one (1) year unless terminated earlier by either party;

**WHEREAS**, the agreement aims to support the Murcia Main Primary Care Facility in meeting the licensing standards of the Department of Health (DOH) by providing service augmentation in key areas;

**WHEREAS**, Committee on Health, finding all the necessary documents to be in order, deemed it best to approve the same;
