**RESOLUTION GRANTING AUTHORITY TO THE PROVINCIAL GOVERNOR, TO SIGN FOR AND ON BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL THROUGH THE CADIZ DISTRICT HOSPITAL AND THE STATE UNIVERSITY OF NORTHERN NEGROS (SUNN) RELATIVE TO THE CONDUCT OF FREE HIV TESTING AND OTHER PUBLIC HEALTH AWARENESS OF BOTH PARTIES, AND EFFECTIVE FOR TWO (2) YEARS FROM THE DATE OF SIGNING AND MAY BE RENEWED OR TERMINATED UPON WRITTEN NOTICE**

**WHEREAS**, the request from Gov.
