RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE NEGROSANON YOUNG LEADERS INSTITUTE, INC. AND THE PROVINCE OF NEGROS OCCIDENTAL RELATIVE TO THE PARTNERSHIP OF BOTH PARTIES FOR THE PURPOSE OF PROVIDING PSYCHOLOGICAL SERVICES IN THE CENTER-BASED AND COMMUNITY-BASED MENTAL HEALTH INTERVENTION AT HULOT SANG PAMATAN-ON, A PHYSICAL SAFE SPACE CENTER FOR CHILDREN AND YOUTH ON NEGROS OCCIDENTAL, MANAGED BY THE FIRST PARTY
