CHARITY MONDRAGON-BAYAWA RELATIVE TO THE ENGAGEMENT OF HER SERVICES AS CONSULTANT ON ANESTHESIOLOGY AT THE DON SALVADOR BENEDICTO MEMORIAL HOSPITAL FOR THE PERIOD JUNE 1, 2025 TO DECEMBER 31, 2025***

***WHEREAS***, thereby presented to the Board for review and appropriate action is the request of the Governor for authority to sign, for and in behalf of the Province, the Consultancy Agreement to be entered into by and between the Province of Negros Occidental and Dr. Charity Mondragon-Bayawa relative to the engagement of her services as Consultant on Anesthesiology at the Don Salvador Benedicto Memorial Hospital for the period June 1, 2025 to December 31, 2025;

***WHEREAS***, under said agreement, the province shall pay Dr. Charity Mondragon-Bayawa on a monthly basis the sum of Twenty Thousand Pesos (P20,000.00) for services rendered as Consultant on Anesthesiology;
