RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN FOR AND IN BEHALF OF THE PROVINCE THE CONSULTANCY AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND DR. CLAYTON JOHN B. CHUA RELATIVE TO THE ENGAGEMENT OF HIS SERVICES AS NEONATOLOGIST CONSULTANT AT THE TERESITA L. JALANDONI PROVINCIAL HOSPITAL FOR THE PERIOD JANUARY 1, 2025 – DECEMBER 31, 2025

WHEREAS, thereby presented to the Board for review and appropriate action is the request of the Governor for the approval and authority to sign the Consultancy Agreement to be entered into by and between the Province of Negros Occidental and Dr. Clayton John B. Chua relative to the engagement of his services as Neonatologist Consultant at the Teresita L. Jalandoni Provincial Hospital for the period January 1, 2025 to December 31, 2025;

WHEREAS, Ordinance No. 004, series of 2008 allows private doctors, consultants and other technical experts to practice in the Provincial Government owned hospital (s);

WHEREAS, Dr. Chua shall receive, manage and answer referrals of neonatology cases at the Teresita L. Jalandoni Provincial Hospital;

WHEREAS, Dr. Chua shall serve as Neonatologist Consultant, conducting rounds twice weekly at the TLJPH, for a monthly fee of Thirty Thousand Pesos (P30,000.00);

WHEREAS, the Consultancy Agreement is in order and conforms to the requirements on the law of contracts;
