RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND ZRL GROUP, INC. RELATIVE TO THE IMPLEMENTATION OF COST-SHARING ARRANGEMENTS UNDER THE UPDATED PHILHEALTH HEMODIALYSIS TREATMENT PACKAGE AND TO RECONCILE PAYMENT OBLIGATIONS COVERING THE PERIODS JUNE 28, 2024 TO FEBRUARY 13, 2025

WHEREAS, thereby presented for appropriate action of the Board is the request for authority to the Provincial Governor to sign, for and in behalf of the province the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental and ZRL Group, Inc. relative to the implementation of cost-sharing arrangements under the updated PhilHealth Hemodialysis Treatment Package and to reconcile payment obligations covering the periods June 28, 2024 to February 13, 2025;

WHEREAS, the agreement outlines the updated sharing arrangement of PhilHealth's Hemodialysis Treatment Package rates in accordance with PhilHealth Circulars Nos. 2024-0014 and 2024-0023, as well as the Implementing Rules and Regulations (IRR) dated May 22, 2025;

WHEREAS, the arrangement is consistent with the provisions of Republic Act No. 11223 (Universal Health Care Act) and relevant PhilHealth circulars. It also aligns with the Local Government Code of 1991 (RA 7160), particularly Sections 465(b)(l)(vi) and 22 (c), which authorizes the Local Chief Executive to enter into contracts for the delivery of essential health services, subject to Sangguniang Panlalawigan approval;
