## RESOLUTION NO. 0683 Series of 2025

RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE NEGROS OCCIDENTAL TENNIS ASSOCIATION (NOTA) AND THE PROVINCE OF NEGROS OCCIDENTAL RELATIVE TO THE USE OF THE PANAAD TENNIS COURT BY NOTA FREE OF CHARGE FOR A PERIOD OF 3 YEARS STARTING JUNE 2025 TO JUNE 2028

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is the Memorandum of Agreement to be entered into by and between the Negros Occidental Tennis Association (NOTA) and the Province of Negros Occidental relative to the use of the Panaad Tennis Court by NOTA free of charge for a period of 3 years starting June 2025 to June 2028;

WHEREAS, the MOA provides that the province will allow NOTA to use the Pana-ad Tennis Courts, a property owned by the province, free of charge, for a period of 3 years starting June 2025 to June 2028, renewable for another three (3) years at the option of NOTA and the provi9nce retains the right to use the facility for its own sports programs and activities, including those sponsored by the DepEd, and for other local, national and international events;

WHEREAS, while NOTA will not be required to pay rent of use fees, it shall assume full responsibility for maintaining the facilities, including incurring necessary and useful expenses for upkeep, utilities (electric and water) and the installation of electric lines and a separate electric meter;

**WHEREAS**, the Committee on Government Assets, finding the subject agreement to be favorable and all the necessary documents to be in order, deemed it best to approve the same:
