RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PRIVATE SCHOOLS ATHLETIC ASSOCIATION (PRISAA) AND THE PROVINCE OF NEGROS OCCIDENTAL RELATIVE TO THE PARTNERSHIP OF BOTH PARTIES WITH REGARD TO THE CONDUCT OF THE 2026 NATIONAL PRISAA GAMES WHICH WILL BE HELD IN BACOLOD CITY, NEGROS OCCIDENTAL ON MAY 8-16, 2026

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is the Memorandum of Agreement to be entered into by and between the Private Schools Athletic Association (PRISAA) and the Province of Negros Occidental relative to the partnership of both parties with regard to the conduct of the 2026 National PRISAA Games which will be held in Bacolod City, Negros Occidental on May 8-16, 2026;

WHEREAS, the MOA provides that the province, as the Host Province, has the responsibility to provide free of charge to the PRISAA the playing venues and sports facilities within the Panaad Park and Stadium and all other facilities owned and supervised by the Host Province outside the Panaad Park and Stadium;

WHEREAS, the PRISAA, on the other hand, has the responsibility to establish a PRISAA Secretariat which shall be responsible for planning, registration of all participants, coordination with the different PRISAA Regional Chapters and overall operations of the 2026 PRISAA National Games, handle all technical requirements of the games, and to comply with the guidelines pertaining to the use and upkeep of the Panaad Park and Stadium, its facilities and sports equipment, and all other playing venues owned and supervised by the Host Province, among others;
