RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE THE MEMORANDUM OF UNDERSTANDING TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL, INTERNATIONAL COLLEGE OF ADVANCED EDUCATION (ICAE) AND THE RECIPIENTS OF THE NORTHERN TERRITORY, AUSTRALIA SCHOLARSHIP UNDER THE "STUDY NOW, PAY LATER" PROGRAM OF THE PROVINCE RELATIVE TO THE GRANT OF A FULL FUNDING TWO-YEAR TRAINING PROGRAM ON COMMERCIAL COOKERY TO QUALIFIED NEGRENSE PROFESSIONALS AT THE ICAE IN NORTHERN TERRITORY, AUSTRALIA

WHEREAS, thereby presented for appropriate action of the Board is the request for authority to the Provincial Governor to sign, for and in behalf of the province the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental, International College of Advanced Education (ICAE) and the recipients of the Northern Territory, Australia Scholarship under the "Study Now, Pay Later" Program of the province relative to the grant of a full funding two-year training program on commercial cookery to qualified Negrense professionals at the ICAE in Northern Territory, Australia;

WHEREAS, the agreement is in line with the constitutional mandate, specifically Article II, Section 17 and Article XIV, Section 1 which provides that:

"The State shall give priority to education, science and technology, arts, culture, and sports to foster patriotism and nationalism, accelerate social progress, and promote total human liberation and development"

"The State shall protect and promote the right of all citizens to quality education at all levels, and shall take appropriate steps to make such education accessible to all"
