RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 04, SERIES OF 2025 OF THE CITY OF VICTORIAS, NEGROS OCCIDENTAL COVERING THE FY 2025 SUPPLEMENTAL BUDGET NO. 4 OF THE SAID CITY IN THE AMOUNT OF SEVENTY ONE MILLION FOUR HUNDRED THIRTY NINE THOUSAND THREE HUNDRED SEVENTY NINE PESOS AND EIGHTY SEVEN CENTAVOS (P71,439,379.87)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the FY 2025 Supplemental Budget No. 4 of the City of Victorias, Negros Occidental, with a total appropriation of Seventy One Million Four Hundred Thirty Nine Thousand Three Hundred Seventy Nine Pesos and Eighty Seven Centavos (P71,439,379.87), enacted by the Sangguniang Panlungsod per Appropriation Ordinance No. 04, Series of 2025;

WHEREAS, the above-mentioned budget shows apparent compliance with the same law, its Implementing Rules and Regulations, Budget Operations Manual for Local Government Units, 2023 Edition and implementing circulars and other issuances;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;

NOW THEREFORE, on motion of Hon. Laurence Marxlen J. Dela Cruz, unanimously seconded by all the members present,

Ordinance No. 04, Series of 2025 of the City of Victorias, Negros Occidental, subject to the posting requirement under Section 59 of the LGC 1991, and to the following condition and reminder:

1. The utilization of the 20% Development Fund shall be utilized and disbursed in accordance with the provisions of Joint Memorandum Circular (JMC) No. 1 of the Department of Budget and Management, Department of Finance and the Department of Interior and Local Government dated November 4, 2020.
2. The purchase and specifications of the motor vehicles shall be subject to the provisions of Administrative Order No. 14 dated December 10, 2018; Budget Circular No. 2022-1 dated February 11, 2022 and Budget Circular No. 2022-1A dated March 1, 2023 of the DBM.

RESOLVED FURTHER, that the review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of the law.

RESOLVED FINALLY, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the city government.

This resolution shall take effect immediately upon approval.
