WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Resolution No. 25-229 of the City of Bago approving Resolution No. 10, series of 2025 of the CDC Executive Committee, Bago City entitled: Resolution approving the Supplemental Annual Investment Program (AIP) No. 6 in the amount of P22,407,524.67;
