RESOLUTION APPROVING RESOLUTION NO. 2025-030 OF THE MUNICIPALITY OF SAN ENRIQUE AUTHORIZING/APPROVING THE RE-ALIGNMENT / REPROGRAMMING OF 1% LCPC FUND FOR CY 2025 THEREBY APPROVING LCPC RESOLUTION NO. 1, SERIES OF 2025 OF THE MUNICIPALITY OF SAN ENRIQUE, NEGROS OCCIDENTAL

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Resolution No. 2025-030 of the Municipality of San Enrique authorizing/approving the re-alignment / reprogramming of 1% LCPC Fund for CY 2025 thereby approving LCPC Resolution No. 1, series of 2025 of the Municipality of San Enrique, Negros Occidental;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject resolution reveals that the same is within the power of the Sangguniang Bayan of the Municipality of San Enrique to enact and in accordance with the Section 56 of R.A. 7160, otherwise known as the Local Government Code of 1991, mandating LGUs to formulate their local development plans and public investment programs and activities based on their respective thrusts and priorities and the same was approved by their Municipal Development Council;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;
