**AN ORDINANCE APPROPRIATING THE AMOUNT OF FOUR HUNDRED THIRTY TWO MILLION SIX HUNDRED TWENTY NINE THOUSAND TWO HUNDRED FOUR PESOS (P432,629,204.00) FOR THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 4 OF THE PROVINCE OF NEGROS OCCIDENTAL AND THE CREATION OF FIVE (5) ADMINISTRATIVE AIDE III (DRIVER I), SG 3 AND ONE (1) FOOD SERVICE SUPERVISOR II, SG 11 - CASUAL POSITIONS UNDER THE PROVINCIAL ADMINISTRATOR'S OFFICE**

**SECTION 2. CREATION** – There is hereby created Six (6) casual positions under the Provincial Administrator’s Office to wit:

**SECTION 3.** Pursuant to Section 336 of RA 7160 otherwise known as the Local Government Code of 1991, the Provincial Governor or the Presiding Officer of the Sangguniang Panlalawigan, by virtue of this ordinance, is hereby authorized to augment any item in the approved supplemental budget for their respective offices from savings in other items within the same expense class of their respective appropriations.

**SECTION 3.** This Appropriation Ordinance shall take effect immediately upon approval.
