LACSON, TO SIGN FOR AND ON BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND THE CORAZON LOCSIN MONTELIBANO MEMORIAL REGIONAL HOSPITAL (CLMMRH)-MENTAL HEALTH UNIT RELATIVE TO THE DELIVERY OF MENTAL HEALTH SERVICES, INCLUDING PSYCHOLOGICAL AND PSYCHIATRIC ASSESSMENTS, COUNSELING, PSYCHO-EDUCATION AND PSYCHOLOGICAL INTERVENTIONS OF PATIENTS REFERRED BY THE PROVINCE
