RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS, UNIFIED PROJECT MANAGEMENT OFFICE – BRIDGES MANAGEMENT CLUSTER (DPWH-UPMO-BMC) RELATIVE TO THE OCCUPANCY OF THE AREA OF THE PROVINCIAL ENGINEERING OFFICE OF 5,000 SQUARE METERS LOCATED AT PEO MOTOR POOL IN PAGLA-UM VILLAGE, BACOLOD CITY AS ITS DEPOT AND STOCKYARD OF BRIDGING MATERIALS, INSTALLATION OF EQUIPMENT AND SPARE PARTS WITH AN APPROPRIATE WORKSHOP

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental and the Department of Public Works and Highways, Unified Project Management Office – Bridges Management Cluster (DPWH-UPMO-BMC) relative to the occupancy of the area of the Provincial Engineering Office of 5,000 square meters located at PEO Motor Pool in Pagla-um Village, Bacolod City as its depot and stockyard of bridging materials, installation of equipment and spare parts with an appropriate workshop;

WHEREAS, the said MOA covers the temporary use of 5,000 square meters within the PEO Motor Pool in Pagla-um Village, Mansilingan, Bacolod City that will serve as a depot stockyard and workshop for bridge materials and equipment under the Tulay ng Pangulo para sa Kaunlarang Pang-Agraryo (TPKP) Project and Mega Bridges for Urban and Rural Development Program (MBURDP) of the UPMO-BMC.;

WHEREAS, the Committee on Government Assets, finding the subject agreement to be favorable and all the necessary documents to be in order, deemed it best to approve the same;
