RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 03, SERIES OF 2025 OF THE MUNICIPALITY OF ILOG, NEGROS OCCIDENTAL, COVERING THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 3 OF THE SAID MUNICIPALITY IN THE AMOUNT OF EIGHT MILLION SEVEN HUNDRED THOUSAND PESOS (P8,700,000.00)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2025 General Fund Supplemental Budget No. 3 of the Municipality of Ilog, Negros Occidental with a total appropriation of P8,700,000.00, enacted by the Sanggunian Bayan per Appropriation Ordinance No. 03, series of 2025;
