RESOLUTION GRANTING AUTHORITY TO THE PROVINCIAL GOVERNOR, HON. EUGENIO JOSE V. LACSON, TO SIGN FOR AND ON BEHALF OF THE PROVINCE, THE DEED OF DONATION (DOD) TO BE EXECUTED BY THE PROVINCE OF NEGROS OCCIDENTAL IN FAVOR OF THE CITY OF SIPALAY RELATIVE TO THE DONATION OF FRUIT TREE SEEDLINGS AND VARIOUS EQUIPMENTS IN THE TOTAL AMOUNT OF ONE MILLION FORTY SIX THOUSAND SEVEN HUNDRED FORTY PESOS (P1,046,740.00)
