# RESOLUTION NO. 0761 Series of 2025

RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL, LM CULTURE FOUNDATION INC. AND THE GRANTEES OF THE VISUAL ARTIST GRANT RELATIVE TO THE IMPLEMENTATION OF A VISUAL ARTS GRANT PROGRAM, WHICH WILL SUPPORT THE ARTISTS THROUGH A THREE-WEEK MENTORED FELLOWSHIP AND RESIDENCY PROGRAM AT THE ORANGE PROJECT WHEREIN THE PROVINCE WILL PROVIDE FUNDING IN THE AMOUNT OF ONE HUNDRED THOUSAND PESOS (P100,000.00), COMPOSED OF A TRAINING FEE AND TRANSPORTATION ALLOWANCE TO SUPPORT THE GRANTEES PARTICIPATION IN THE PROGRAM CHARGED AGAINST THE GRANTS AND DONATION OF THE OFFICE OF THE GOVERNOR

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental, LM Culture Foundation Inc. and the grantees of the visual artist grant relative to the implementation of a Visual Arts Grant Program, which will support the artists through a three-week mentored fellowship and residency program at the Orange Project wherein the province will provide funding in the amount of One Hundred Thousand Pesos (P100,000.00), composed of a training fee and transportation allowance to support the grantees participation in the program charged against the Grants and Donation of the Office of the Governor;
