RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE THE SPECIFIC ROAD PROJECTS CHARGEABLE AGAINST THE LUMP-SUM APPROPRIATION UNDER SB. NO. 3, SERIES OF 2025 – CONSTRUCTION/UPGRADING OF PROVINCIAL ROAD AND OTHER ROAD NETWORK AND INFRASTRUCTURES IN THE TOTAL AMOUNT OF ONE HUNDRED THREE MILLION TWO HUNDRED FIFTY THOUSAND PESOS (P103,250,000.00) AND TO ENTER INTO CONTRACT RELATIVE THERETO

This resolution shall take effect immediately upon approval.


