**RESOLUTION REQUESTING FOR THE ISSUANCE OF AN ELECTRONIC CERTIFICATE AUTHORIZING REGISTRATION (eCAR), LOCAL TAX CLEARANCES AND THE NEW TITLE IN THE NAME OF THE PROVINCE OF NEGROS OCCIDENTAL, RELEVANT TO THE SALE OF LOT IN 1151, LOCATED AT LA CASTELLANA, NEGROS OCCIDENTAL TO THE PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL, AND AUTHORIZING MS. DANISE JANSEN TIANGSON, MR. RENANTE CAPITLE AND MR. NEIL MAPA TO FILE, PAY, SUBMIT, PROCESS AND CLAIM ALL RELATED AND NECESSARY DOCUMENTS ON BEHALF OF THE PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL**

**WHEREAS**, Section 16, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that Local Government Units (LGUs) shall exercise powers necessary, appropriate or incidental for their efficient and effective government and those which are essential to the promotion of the general welfare;

**WHEREAS**, the Provincial Government of Negros Occidental recognizes the necessity of securing the Electronic Certificate Authorizing Registration (eCAR), local tax clearances, and the new title in the name of the Province of Negros Occidental relevant to Lot No. 1151, located at La Castellana, Negros Occidental, for legal, financial, and administrative compliance with government requirements, which will be done through appointing and granting authority to the above-mentioned representatives;

**WHEREAS**, in view of the foregoing, the SP Committee on Laws, finding the documents to be in order, deemed it best to approve the same;
