**WHEREAS**, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Resolution No. 072, series of 2025 of the Municipality of Manapla approving the 2025 Supplemental Annual Investment Program (AIP) the priority proposed project of the Municipality of Manapla to be funded under the 2021 LDRRM Special Trust Fund as endorsed by the Municipal Development Council in its Resolution No. 04, series of 2025;

**WHEREAS**, a review of the subject resolution reveals that the same is within the power of the Sangguniang Bayan of the Municipality of Manapla to enact and consistent with national, regional and provincial DRRM priorities and the LGU is strongly encouraged to utilize the allocated budget effectively to enhance its coordination and response mechanisms in the municipality, subject to the provisions of Section 21 of RA 10121 and COA Audit Circular No. 2012-002;
