RESOLUTION APPROVING RESOLUTION NO. 2024-329 OF THE CITY OF TALISAY, NEGROS OCCIDENTAL, APPROVING CDC RESOLUTION NO. 199, SERIES OF 2024, THEREBY APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) FOR CY 2024 FOR THE RE-PROGRAMING OF SAVINGS FROM THE 5% LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND (LDRRMF) IN THE AMOUNT OF ONE MILLION THREE HUNDRED TWENTY TWO THOUSAND PESOS (P1,322,000.00)

WHEREAS, thereby presented to the Board for review and appropriate action is Resolution No. 2024-329 of the City of Talisay, approving CDC Resolution No. 199, series of 2024, thereby approving the Supplemental Investment Program (SIP) for CY 2024 for the re-programing of savings from the 5% Local Disaster Risk Reduction and Management Fund (LDRRMF) in the amount of One Million Three Hundred Twenty Two Thousand Pesos (P1,322,000.00);

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, said Resolution was approved by the Sangguniang Panlungsod of the City of Talisay on December 16, 2024 but was forwarded to the Sangguniang Panlalawigan for review only on July 2, 2025;
