RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2025-01 OF THE MUNICIPALITY OF CALATRAVA, NEGROS OCCIDENTAL COVERING THE FY 2025 SUPPLEMENTAL BUDGET NO. 1 OF THE SAID MUNICIPALITY IN THE AMOUNT OF SIXTY ONE MILLION FOUR HUNDRED FIFTY TWO THOUSAND EIGHT HUNDRED PESOS (#61,452,800.00)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the FY 2025 Supplemental Budget No. 1 of the Municipality of Calatrava, Negros Occidental, with a total appropriation of Sixty One Million Four Hundred Fifty Two Thousand Eight Hundred Pesos (₱61,452,800.00), enacted by the Sangguniang Bayan per Appropriation Ordinance No. 2025-01;

WHEREAS, the above-mentioned budget shows apparent compliance with the same law, its Implementing Rules and Regulations, Budget Operations Manual, 2023 Edition for Local Government Units and implementing circulars and other issuances, as pre-reviewed and endorsed by the Local Finance Committee through the Provincial Budget Office;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 2025-01 of the Municipality of Calatrava, Negros Occidental, subject to the following conditions and reminders:

- The utilization of the 20% Development Fund shall be utilized and disbursed in accordance with the provisions of Joint Memorandum Circular No. 1 of the Department of Budget and Management, Department of Finance and the Department of Interior and Local Government dated November 4, 2020.
- The purchase and specification of the motor vehicles shall be subject to the provisions of Administrative Order No. 14 dated December 10, 2018; Budget Circular No. 2022-1 dated February 11, 2022 and Budget Circular No. 2022-1A dated March 1, 2023 of the DBM;
- The night shift differential shall be in accordance with RA No. 11701, Item 6.0 of DOH-DBM JC No. 1 dated November 29, 2012, and CSC-DBM-GCG-JC No. 1 dated August 1, 2023.
- 4. The appropriation for Donations shall be spent solely for public purpose pursuant to Sections 205 (b), 335 and 351 of the Local Government Code.

RESOLVED FURTHER, that the review action does not authorize any item appropriation that is specifically prohibited by or inconsistent with the provisions of laws.

RESOLVED FURTHERMORE, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the municipal government.

RESOLVED FINALLY, that compliance with the existing laws, rules and regulations shall be the responsibility of the municipality.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
