RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2025-02 OF THE MUNICIPALITY OF HINOBA-AN, NEGROS OCCIDENTAL, COVERING THE FY 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 2 OF THE SAID MUNICIPALITY IN THE AMOUNT OF TEN MILLION TWO HUNDRED PESOS (P10,200,000.00)

WHEREAS, thereby presented to the Board for review and appropriate action is the FY 2025 General Fund Supplemental Budget No. 2 of the Municipality of Hinoba-an, Negros Occidental with a total appropriation of Ten Million Two Hundred Pesos (P10,200,000.00), enacted by the Sangguniang Bayan per Appropriation Ordinance No. 2025-02;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. 7160, otherwise known as the Local Government Code of 1991, Budget Operations Manual for Local Government Units, 2023 Edition and implementing circulars and other issuances, as pre-reviewed and endorsed by the Provincial Budget Office and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve and declare operative in its entirety the Appropriation Ordinance No. 2025-02 of the Municipality of Hinoba-an, Negros Occidental, subject to the posting requirement under Section 59 of the Local Government Code (LGC) of 1991, and further subject to the following conditions and reminders:

- That Section 56 in relation with Section 326 of the LGC provides that within three

 (3) days after approval of the Ordinance authorizing annual/supplemental appropriation, the Secretary to the Sanggunian shall forward the said Ordinance to the appropriate reviewing authority;
- That Section 54 of the LGC provides that every ordinance enacted by the sangguniang bayan shall be presented to the municipal mayor, as the case may be. If the LCE concerned approves the same, he shall affix his signature on each and every page thereof.

RESOLVED FURTHER, that this Resolution does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

RESOLVED FURTHERMORE, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the municipal government and that compliance with the existing laws, rules and regulations shall be the responsibility of the municipality.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
