WHEREAS, the Energy Sector Council created under Section 16 of the said Ordinance as an expansive participatory unit from all walks of life to include Government as well as Non-Government Organization or People's Organization in order to properly represent and echo the voice of the entire Province of Negros Occidental as far as renewable energy development and security is concerned;

WHEREAS, the interim steering committee must be organized in a manageable number of key personnel that may be selected at the discretion of the Chairman and delegating the matter to the Vice-Chairman;

WHEREAS, with the advent of the Interim Committee core group, it will open the doorway for qualified or accredited members to be recognized for inclusion in this Energy Sector Council so that it can pursue other interrelated activities such as the summit workshop to formulate the Provincial Energy Code;

NOW THEREFORE, on motion of hon. Sixto Teofilo Roxas V. Guanzon, Jr., unanimously seconded by all the members present,
