RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2025-05 OF THE CITY OF LA CARLOTA, NEGROS OCCIDENTAL, COVERING THE FY 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 5 OF THE SAID CITY IN THE AMOUNT OF FOUR HUNDRED NINETY THREE THOUSAND SEVEN HUNDRED THIRTY TWO PESOS (P493,732.00)

WHEREAS, thereby presented to the Board for review and appropriate action is the FY 2025 General Fund Supplemental Budget No. 5 of the City of La Carlota, Negros Occidental with a total appropriation of Four Hundred Ninety Three Thousand Seven Hundred Thirty Two Pesos (P493,732.00), enacted by the Sangguniang Panlungsod per Appropriation Ordinance No. 2025-05;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. 7160, otherwise known as the Local Government Code of 1991, Budget Operations Manual for Local Government Units, 2023 Edition and implementing circulars and other issuances, as pre-reviewed and endorsed by the Provincial Budget Office and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve and consider operative in its entirety effective July 24, 2025, the Appropriation Ordinance No. 2025-05 of the City of La Carlota, Negros Occidental, subject to the posting requirements under Section 59 of the Local Government Code of 1991 and the reminder that the local government unit must indicate the proper Annual Investment Plan (AIP) Reference Code under column three (3) of Local Budget Preparation Form No. 9. The AIP Reference Code is vital to ensuring the Plan-Budget Linkage. The code assigned to each PPA facilitates validation of whether or not the PPAs funded in the budget are the same PPAs prioritized in the AIP.

RESOLVED FURTHER, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the city government.
