## **RESOLUTION NO. 0809** Series of 2025

RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 4, SERIES OF 2024 OF THE CITY OF TALISAY, NEGROS OCCIDENTAL ENTITLED: "AN ORDINANCE APPROPRIATING THE AMOUNT OF SIXTY-SIX MILLION SEVEN HUNDRED EIGHTY SEVEN THOUSAND FOUR HUNDRED TWO PESOS AND 59/100 (P66,787,402.59) FOR THE ADDITIONAL APPROPRIATION TO THE NEWLY IDENTIFIED PROGRAMS AND PROJECTS IN THE CITY, AND FOR THE GRANT OF PERFORMANCE BASED BONUS AND OTHER PERSONNEL, BENEFITS OF THE CITY OFFICIALS AND EMPLOYEES OF THE CITY OF TALISAY, NEGROS OCCIDENTAL"

WHEREAS, thereby presented to the Board for review and appropriate action is Appropriation Ordinance No. 4, Series of 2024 of the City of Talisay, Negros Occidental entitled: "AN ORDINANCE APPROPRIATING THE AMOUNT OF SIXTY-SIX MILLION SEVEN HUNDRED EIGHTY SEVEN THOUSAND FOUR HUNDRED TWO PESOS AND 59/100 (P66,787,402.59) FOR THE ADDITIONAL APPROPRIATION TO THE NEWLY IDENTIFIED PROGRAMS AND PROJECTS IN THE CITY, AND FOR THE GRANT OF PERFORMANCE BASED BONUS AND OTHER PERSONNEL, BENEFITS OF THE CITY OFFICIALS AND EMPLOYEES OF THE CITY OF TALISAY, NEGROS OCCIDENTAL";

WHEREAS, the pre-review shows apparent compliance with the same law and its Implementing Rules and Regulations, Budget Operations Manual for Local Government Units, 2023 Edition and with implementing circulars and other issuances;

WHEREAS, the same is therefore recommended for approval and considered operative in its entirety subject to the posting requirements under Section 59 of LGC 1991 WITH the following conditions, to wit:

- The utilization of Local Disaster Risk Reduction and Management Fund shall be in accordance with RA 10121 and its Implementing Rules and Regulations, COA Circular No. 2012-02 dated September 12, 2012 and NDRRMC- DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013;
- The grant of Service Recognition Incentive (SRI) shall be in accordance with the provisions of Budget Circular No. 2024-7, dated December 16, 2024 of the Department of Budget and Management;
- 3. The disbursement of the appropriation for Other Personnel Benefits shall strictly be in accordance with the existing laws/issuances on compensation and personnel benefits and that a copy of the Revised Plantilla of Personnel shall be furnished to the Provincial Budget Office, in case of Salary Adjustment; and
- 4. Strict adherence in the period as to the submission of Appropriation Ordinances to the Sangguniang Panlalawigan for review per Section 56(a) of RA 7160, which states that: "Review of Component City and Municipal Ordinances or Resolutions by the Sangguniang Panlalawigan (a) Within Three (3) days after approval, the secretary to the Sangguniang Panlungsod or Sangguniang Bayan shall forward to the Sangguniang Panlalawigan for review, copies of the approved ordinances and the resolutions approving the local development plans and public investment programs formulated by the local development councils".

WHEREAS, in view of the foregoing, the SP Committee on Finance, finding the documents to be in order, deemed it best to approve the same;

**NOW THEREFORE**, on motion of Hon. Laurence Marxlen J. Dela Cruz, unanimously seconded by all members present;
