RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2025-03 OF THE MUNICIPALITY OF BINALBAGAN, NEGROS OCCIDENTAL, COVERING THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 3 OF THE SAID MUNICIPALITY IN THE AMOUNT OF TWENTY SEVEN MILLION FIVE HUNDRED NINETY TWO THOUSAND SIX HUNDRED SIXTY FIVE PESOS (P27,592,665.00)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2025 General Fund Supplemental Budget No. 3 of the Municipality of Binalbagan, Negros Occidental with a total appropriation of P27,592,665.00, enacted by the Sanggunian Bayan per Appropriation Ordinance No. 2025-03;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991, and Joint Circular No. 93-2 of the Commission on Audit and the Department of Budget and Management dated June 8, 1993 and other implementing circulars and issuances, as pre-reviewed and endorsed by the Provincial Budget Officer and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 2025-03 of the Municipality of Binalbagan covering the 2025 General Fund Supplemental Budget No. 3 of the said municipality with a total appropriation of P27,592,665.00 and considered operative in its entirety subject to the posting requirement under Section 59 of LGC 1991 and subject further to the following conditions:

1. the utilization of the 5% Local Disaster Risk Reduction and Management Fund shall be in accordance with the provisions of RA 10121 and its IRR, COA Circular No. 2012-02 dated September 12, 2012 and NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013;
2. the purchase and specifications of the motor vehicles shall be subject to the provisions of Administrative Order No. 14, dated December 10, 2018; BC No. 2022-1 dated February 11, 2022 and BC No. 2022-1A dated March 1, 2023 of the DBM;

RESOLVED FURTHER, that the accuracy of the statement/certification and other supporting documents contained in this supplemental budget as well as the observance with other existing laws, rules and regulations shall be the responsibility of the municipal government.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
