

RESOLUTION APPROVING RESOLUTION NO. 2025-036 OF THE MUNICIPALITY OF SAN ENRIQUE CONCURRING MDC RESOLUTION NO. 03, SERIES OF 2025 OF THE MUNICIPALITY OF SAN ENRIQUE, NEGROS OCCIDENTAL, THEREBY APPROVING THE CY 2025 SUPPLEMENTAL INVESTMENT PROGRAM NO. 01 AMOUNTING TO P2,700,000.00 FOR VARIOUS PROGRAMS AND PROJECTS

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Resolution No. 2025-036 of the Municipality of San Enrique concurring MDC Resolution No. 03, series of 2025 of the Municipality of San Enrique, Negros Occidental, thereby approving the CY 2025 Supplemental Investment Program No. 01 amounting to P2,700,000.00 for various programs and projects;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject resolution reveals that the same is within the power of the Sangguniang Bayan of the Municipality of San Enrique to enact and in accordance with the Section 56 of R.A. 7160, otherwise known as the Local Government Code of 1991, mandating LGUs to formulate their local development plans and public investment programs and activities based on their respective thrusts and priorities and the same was approved by their Municipal Development Council;

WHEREAS, the allocation/appropriation of the 20% Development Fund of the LGU is aligned with Section 288 of RA 7160 directing LGUs to appropriate in its budget no less than 20% of its IRA/NTA for development projects;
