**RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 04, SERIES OF 2025 OF THE MUNICIPALITY OF ISABELA, NEGROS OCCIDENTAL AUTHORIZING THE MUNICIPAL MAYOR TO AUGMENT ANY ITEM IN THE APPROVED 2025 ANNUAL BUDGET IN THE EXECUTIVE OFFICE FROM SAVINGS IN OTHER ITEMS WITHIN THE SAME EXPENSE CLASS PURSUANT TO SECTION 336 OF RA 7160 OTHERWISE KNOWN AS THE 1991 LOCAL GOVERNMENT CODE EFFECTIVE UPON ITS APPROVAL**

**WHEREAS**, thereby presented to the Board for review and appropriate action is the Municipal Ordinance No. 04, series of 2025 of the Municipality of Isabela, Negros Occidental authorizing the Municipal Mayor to augment any item in the Approved 2025 Annual Budget in the Executive Office from savings in other items within the same expense class pursuant to Section 336 of RA 7160 otherwise known as the 1991 Local Government Code effective upon its approval;

**WHEREAS**, the enactment of the subject ordinance find legal basis under Section 336 of RA 7160, which authorizes the local chief executives to augment any item in the approved annual budget from savings in other items within the same expense class, provided authority is granted through the ordinance;

**WHEREAS**, Section 59 of RA 7160 states that the secretary to the sanggunian concerned shall cause the posting of an ordinance in a bulletin board at the entrance of the provincial capitol, city, municipality or barangay hall, and in at least two (2) conspicuous places in the local government unit concerned not later than five (5) days after approval thereof. Such posting requirement is necessary for the validity and affectivity of the ordinance;
