RESOLUTION APPROVING ON SECOND READING THE PROPOSED ORDINANCE INSTITUTIONALIZING THE ANNUAL CELEBRATION OF "INDIGENOUS PEOPLES MONTH" IN THE PROVINCE OF NEGROS OCCIDENTAL, DECLARING OCTOBER AS THE OFFICIAL MONTH OF INDIGENOUS PEOPLES, AFFIRMING THE CELEBRATION OF "IP YOUTH DAY" AND THE "INTERNATIONAL DAY OF THE WORLD'S INDIGENOUS PEOPLES," ESTABLISHING MECHANISMS FOR PARTICIPATION, FUNDING, AND PROGRAMMATIC IMPLEMENTATION, AND FOR OTHER PURPOSES

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the proposed ordinance institutionalizing the annual celebration of "Indigenous Peoples Month" in the Province of Negros Occidental, declaring October as the official month of Indigenous Peoples, affirming the celebration of "IP Youth Day" and the "International Day of the World's Indigenous Peoples," establishing mechanisms for participation, funding, and programmatic implementation, and for other purposes;
