**WHEREAS**, thereby presented to the Board for review and appropriate action is Resolution No. 2025-144 of the Municipality of Murcia, adopting/approving Municipal Development Council (MDC) Resolution No. 25-003, Series of 2025, entitled: Resolution Reprogramming Funds from Purchase of Multi-Purpose Vehicle Funded from the 20% Municipal Development Fund CY 2025 to Land Development and Preparation Works for New Government Center;
