
WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Resolution No. 2025-033 of the City of Talisay approving CDC Resolution No. 200, series of 2025, thereby approving the Annual Investment Program (AIP) for CY 2026 of the City of Talisay, Negros Occidental amounting to P5,735,874,615.63;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject resolution reveals that the same is within the power of the Sangguniang Panlungsod of the City of Talisay to enact and in accordance with the Section 56 of R.A. 7160, otherwise known as the Local Government Code of 1991, mandating LGUs to formulate their local development plans and public investment programs and activities based on their respective thrusts and priorities and the same was approved by their City Development Council;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;
