RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 2025-004 OF THE MUNICIPALITY OF CANDONI AUTHORIZING THE MUNICIPAL VICE MAYOR TO ENTER INTO MOAS AND SERVICE CONTRACTS FOR JOB ORDER OR CONTRACTUAL PERSONNEL UNDER THE OFFICE OF THE VICE MAYOR, SANGGUNIANG BAYAN AND SECRETARIAT OFFICES FOR THE PERIOD FROM JULY 1, 2025 TO JUNE 31, 2028 AND FOR OTHER RELATED PURPOSES




WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Municipal Ordinance No. 2025-004 of the Municipality of Candoni authorizing the Municipal Vice Mayor to enter into MOAs and Service Contracts for Job Order or contractual personnel under the Office of the Vice Mayor, Sangguniang Bayan and Secretariat offices for the period from July 1, 2025 to June 31, 2028 and for other related purposes;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject ordinance reveals that the same is within the power of the Sangguniang Bayan of the Candoni to enact pursuant to Section 16 or the General Welfare Clause, as well as Section 445(a)(5) of R.A. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;
