RESOLUTION APPROVING ORDINANCE NO. 25-15 OF THE CITY OF SAN CARLOS ADOPTING POLICIES ON FISCAL DISCIPLINE AND RESPONSIBLE USE OF PUBLIC FUNDS IN THE CITY GOVERNMENT OF SAN CARLOS

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Ordinance No. 25-15 of the City of San Carlos adopting policies on fiscal discipline and responsible use of public funds in the city government of San Carlos;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sanggunian panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject ordinance reveals that the same is within the power of the Sangguniang Panlungsod of the San Carlos to enact pursuant to Section 458(a), Section 16 (General Welfare Clause) and Section 305 of R.A. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;
