LACSON, TO SIGN FOR AND ON BEHALF OF THE PROVINCE, THE DEED OF DONATION (DOD) TO BE EXECUTED BY THE PROVINCE OF NEGROS OCCIDENTAL IN FAVOR OF THE LOCAL GOVERNMENT UNIT (LGU) RECIPIENT RELATIVE TO THE DONATION OF ONE (1) SET OF A MID-RANGE DESKTOP COMPUTER AND ONE (1) SET OF SATELLITE INTERNET EQUIPMENT, INCLUSIVE OF A ONE-YEAR SUBSCRIPTION TO SUPPORT THE DISASTER RISK REDUCTION AND MANAGEMENT FUNCTIONS OF THE LOCAL GOVERNMENT UNIT (LGU)

WHEREAS, thereby presented to the Board for review and appropriate action is the request of the governor for authority, to sign for and on behalf of the province, the Deed of Donation (DOD) to be executed by the Province of Negros Occidental in favor of the Local Government Unit (LGU) recipient relative to the donation of one (1) set of a mid-range desktop computer and one (1) set of satellite internet equipment, inclusive of a one-year subscription to support the Disaster Risk Reduction and Management Functions of the Local Government Unit (LGU);
