ENGUITO AND THE PROVINCE OF NEGROS OCCIDENTAL RELATIVE TO THE SALE OF A 12,021 SQUARE METERS PARCEL OF LAND, IDENTIFIED AS LOT 9-A-11, COVERED BY TCT NO. CARP2019006528 LOCATED AT BRGY. MINOYAN, MURCIA, NEGROS OCCIDENTAL IN THE TOTAL AMOUNT OF SEVEN MILLION EIGHT HUNDRED THIRTEEN THOUSAND SIX HUNDRED FIFTY PESOS (\$\mathbf{P}7,813,650.00)
