RESOLUTION AUTHORIZING THE GOVERNOR TO IMPLEMENT AND FULLY ADOPT THE SECOND TRANCHE SALARY SCHEDULE EFFECTIVE AUGUST 2, 2025 PURSUANT TO LOCAL BUDGET CIRCULAR NO. 165, DATED JULY 18, 2025 OF THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) IMPLEMENTING EXECUTIVE ORDER NO. 64, DATED AUGUST 2, 2024 OF THE OFFICE OF THE PRESIDENT

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is the request of the Governor for the passage of a resolution authorizing him to implement and fully adopt the Second Tranche Salary Schedule effective August 2, 2025 pursuant to Local Budget Circular No. 165, dated July 18, 2025 of the Department of Budget and Management (DBM) implementing Executive Order No. 64, dated August 2, 2024 of the Office of the President;

WHEREAS, the new salary rates shall be in accordance with the Salary Schedules for first Class Provinces provided under "Annex A-1" of LBC No. 165, dated July 18, 2025 of the DBM;

WHEREAS, the amounts needed to implement the salary increase are already included in the Personal Services (PS) appropriation of each office/department under the 2025 Annual Budget of the province as per Section 12(g) of Appropriation Ordinance No. 2024-006;

WHEREAS, the implementation of the salary increase is within the Personal Services (PS) limitation prescribed under Section 325(a) of RA 7160;
