**RESOLUTION GRANTING AUTHORITY TO THE PROVINCIAL GOVERNOR, HON. EUGENIO JOSE V. LACSON, TO SIGN FOR AND ON BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT (MOA) TO BE EXECUTED BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL, THE DEPARTMENT OF AGRICULTURE – NEGROS ISLAND REGION AND MS. RUBY GLIZ C. BARBOSA, CPA RELATIVE TO THE FORMALIZATION OF THE INTER-AGENCY SECONDMENT OF MS. BARBOSA FROM A LOCAL GOVERNMENT UNIT (PGNO) TO A NATIONAL GOVERNMENT AGENCY (DA-NIR) FOR THE PURPOSE OF ASSISTING THE LATTER IN ITS INITIAL OPERATIONS AND INSTITUTIONAL DEVELOPMENT, WITHOUT SEPARATION FROM HER PLANTILLA POSITION IN PGNO**
