RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND THE FEDERATION OF IRRIGATORS ASSOCIATION – CENTRAL NEGROS – BAGO RIVER IRRIGATION SYSTEM, INC. (FIACN-BRIS, INC.) RELATIVE TO THE TURN-OVER AND OPERATION OF A WAREHOUSE FACILITY TO HOUSE THE POST-HARVEST PROCESSING OF CONVENTIONAL RICE PRODUCED AND PROCUREMENT OF FOUR (4) UNITS OF COCOON, THREE (3) UNITS OF RICE MOISTURE CONTENT METER AND ONE (1) UNIT RICE GRADER TO FIACN-BRIS, INC.

WHEREAS, thereby presented to the Board for review and appropriate action is the request of the Provincial Governor for authority to sign, for and in behalf of the Province, the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental and the Federation of Irrigators Association – Central Negros – Bago River Irrigation System, Inc. (FIACN-BRIS, INC.) relative to the turn-over and operation of a warehouse facility to house the post-harvest processing of conventional rice produced and procurement of four (4) units of cocoon, three (3) units of rice moisture content meter and one (1) unit rice grader to FIACN-BRIS, Inc.;

WHEREAS, the subject agreement is legally sound, consistent with relevant statutory provisions, and aligned with the Province's objectives under the Local Government Code, as pre-reviewed by the Provincial Legal Office;
