RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE THE MEMORANDUM OF AGREEMENT (TRIPARTITE AGREEMENT) TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL, URBAN HAZMAT TRANSPORT SERVICES AND INTEGRATED WASTE MANAGEMENT INC., RELATIVE TO THE SETTING OUT OF THE RESPONSIBILITIES OF THE PROVINCE (AS GENERATOR), URBAN TRANSPORT SERVICES (AS TRANSPORTER) AND THE INTEGRATED WASTE MANAGEMENT INC. (AS TREATER) FOR THE PROPER HANDLING, TRANSPORT, TREATMENT AND FINAL DISPOSAL OF ALL HAZARDOUS WASTES FROM THE PROVINCE'S NINE HOSPITALS IN ACCORDANCE WITH APPLICABLE LAWS AND THE RULES AND REGULATION OF THE EMB-DENR

WHEREAS, thereby presented for appropriate action of the Board is the request for authority to the Provincial Governor to sign, for and in behalf of the province the Memorandum of Agreement (Tripartite Agreement) to be entered into by and between the Province of Negros Occidental, Urban Hazmat Transport Services and Integrated Waste Management Inc., relative to the setting out of the responsibilities of the Province (as Generator), Urban Transport Services (as Transporter) and the Integrated Waste Management Inc. (as Treater) for the proper handling, transport, treatment and final disposal of all hazardous wastes from the province's nine hospitals in accordance with the applicable laws and the rules and regulation of the EMB-DENR;

WHEREAS, the subject agreement is compliant with environmental regulations, and clearly establish roles, liabilities, and procedures. It supports Republic Act 6969 (Toxic Substances and Hazardous and Nuclear Wastes Control Act of 1990), and its implementing rules under DENR Administrative Order No. 29, series of 1992, which regulates the proper management of hazardous wastes;

WHEREAS, the agreement is consistent with the LGU's obligation under Section 17 of the Local Government Code (RA 7160) to deliver basic health services and ensure public safety and environment protection;

WHEREAS, the Transporter and Treater are duly accredited by the EMB-DENR, and the agreements include indemnification clauses protecting the Provincial Government from third-party liabilities resulting from improper transport or disposal;

WHEREAS, in view of the foregoing, the SP Committee on Health, finding the same to be in order, deemed it best to approve the same;


NOW THEREFORE, on motion of Hon. Araceli T. Somosa, duly seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to authorize the Provincial Governor to sign, for and in behalf of the province the Memorandum of Agreement (Tripartite Agreement) to be entered into by and between the Province of Negros Occidental, Urban Hazmat Transport Services and Integrated Waste Management Inc., relative to the setting out of the responsibilities of the Province (as Generator), Urban Transport Services (as Transporter) and the Integrated Waste Management Inc.
