RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND EASTERN TELECOMMUNICATIONS PHILIPPINES, INC. (ETPI) RELATIVE TO THE GRANT OF A RIGHT-OF-WAY FOR THE INSTALLATION OF TELECOMMUNICATIONS POLES AND FIBER OPTIC CABLES IN BARANGAY STA. ROSA, MUNICIPALITY OF MURCIA, NEGROS OCCIDENTAL

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental and Eastern Telecommunications Philippines, Inc. (ETPI) relative to the grant of a right-of-way for the installation of telecommunications poles and fiber optic cables in Barangay Sta. Rosa, Municipality of Murcia, Negros Occidental;

WHEREAS, the MOA seeks to grant ETPI a right-of-way within certain provincial government properties located in Brgy. Sta. Rosa, Murcia to install and maintain telecommunication poles, aerial fiber optic cables and other necessary telecommunications appurtenances;

WHEREAS, in consideration of the grant of a right-of-way, ETPI shall provide to the province, free of charge, two (2) Internet Direct Service (IDS) lines at 10 MBPS, co-terminus with the said MOA;

**WHEREAS**, the Committee on Government Assets, finding the subject agreement to be favorable and all the necessary documents to be in order, deemed it best to approve the same;
