LACSON, TO SIGN FOR AND ON BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT (MOA) TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL THROUGH THE TERESITA L. JALANDONI PROVINCIAL HOSPITAL AND THE CITY GOVERNMENT OF SILAY THROUGH ITS PRIMARY CARE FACILITY RELATIVE TO THE PROVISION OF ANCILIARY HEALTHCARE SERVICES INCLUDING PHARMACEUTICAL, DIAGNOSTIC, LABORATORY, IMAGING AND AMBULANCE SUPPORT
