RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND DR. CHARIBEL E. ESCANDELOR RELATIVE TO THE ENGAGEMENT OF HER SERVICES AS CONSULTANT PSYCHIATRIST

WHEREAS, thereby presented to the Board for review and appropriate action is the request of the Provincial Governor for authority to sign, for and in behalf of the Province, the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental and Dr. Charibel E. Escandelor relative to the engagement of her services as Consultant Psychiatrist;
